Unibz presenta annualmente la candidatura per poter partecipare all'Azione Chiave 1 del Programma Erasmus+/Mobilità che prevede la possibilità di finanziare per studenti e docenti mobilità di breve durata nell'ambito di "Blended Intensive Programmes/BIP" e "Short Mobility Initiatives".

L'Agenzia Nazionale Erasmus+ raccomanda che la selezione dei candidati alla mobilità Erasmus+ sia trasparente e prevenga qualsiasi potenziale conflitto di interesse.

Con delibera nr. 27 del 13.05.2024 il Consiglio della Facoltà di Design e Arti ha approvato la Commissione di valutazione e i criteri di selezione di studenti e docenti che intendono candidarsi per i Blended Intensive Programmes di cui all'oggetto.

ERASMUS+ CALL FOR APPLICATIONS: BIP/SHORT MOBILITIES 2024

Blended Intensive Programmes (BIPs) represent an innovative approach to student mobility within the new Erasmus+ 2021-2027 Programme. These programmess, developed collaboratively by multiple higher education institutions, integrate advanced pedagogical methods by combining short-term face-to-face sessions with virtual learning components.

BIPs are inherently transnational and transdisciplinary, as they involve the joint development and teaching of curricula by partner institutions across different countries. The integration of physical and virtual learning environments fosters collaborative, challenge-based, and research-oriented teaching and learning experiences for both students and professors.

The virtual component of the programme allows students to enhance their digital knowledge and skills, aligning with the European Commission's emphasis on leveraging digital technologies for education and fostering digital literacy among all participants.

The University of Bolzano (Unibz), in collaboration with the University of Thessaly (Greece) and the University of Batman (Turkey), offers students the opportunity to participate in the following Blended Intensive Programmes:

GREECE, September 2024: Cross-Mythologies and The Anthropocene: Mesopotamia and Greek Mythos - Interdisciplinary Exploration through Performance, Space, and Poetics

and

TURKEY, October 2024: Cross-Mythologies and The Anthropocene: Mesopotamia and Greek Mythos - Interdisciplinary Exploration through Performance, Space, and Poetics

The following selections are open for participation in the physical program of the aforementioned BIPs. Teaching methodologies include face-to-face lectures, on-field classes, case-study presentations, self-learning, and online group meetings for data analysis and discussion.

1. Calendar

University of Thessaly (Greece): September 22nd – 29th, 2024

Virtual Component: June 2024

Available Mobilities: 7 students + 1 teaching staff

University of Batman (Turkey): October 13th – 20th, 2024

Virtual Component: June 2024

Available Mobilities: 7 students + 1 teaching staff





2. Financial Support

Financial support is provided to facilitate the physical mobility undertaken as part of the Erasmus Unibz BIP.

Students:

The contribution is available to all students admitted to the BIP who complete both the planned physical and virtual mobility components.

Individual Support:

From the 1st to the 14th day of mobility: €79 per day

Additional grants may be provided to support inclusiveness and environmentally friendly travel, with details to be communicated by unibz. Special funding for students with specific health-related needs may be allocated by the European Union, with notifications sent directly to eligible recipients.

Grants received may be subject to refund in cases of mobility renunciation, cancellation due to non-compliance, or failure to achieve a minimum of 3 ECTS credits.

Teaching Staff:

For details regarding amounts, duration, teaching hours, and limitations of the teaching staff grant, refer to the Erasmus Programme Guide (https://erasmus-plus.ec.europa.eu/erasmus-programme-guide - pages 70-71). All expenses must comply with current unibz regulations on missions/business trips.

3. Eligibility Criteria

Students:

Participation is open to students enrolled in the following disciplines and/or degree courses:

- Bachelor in Design and Art
- Master in Eco-Social Design

To be eligible for short-term physical mobility under the BIP, students must adhere to the maximum number of Erasmus mobility days available for each study cycle:

Cycle I and II (bachelor and master): 12 months

Students may undertake multiple Erasmus mobility activities abroad in the same academic year, provided they are not concurrent. Virtual mobility under this Call for Applications is compatible with other international mobility programmes, including Erasmus.

Teaching Staff:

Unibz teaching staff from the Faculty of Design and Art must conduct teaching activities agreed upon with partner institutions and documented in accordance with Erasmus regulations within the framework of the BIP outlined in this call for applications.

4. Selection Criteria and Procedures

A designated committee composed of Secil Ugur Yavuz and Mustapha El Moussaoui will oversee the selection process.

Students:

Selection is based on the evaluation of the following criteria:

For Bachelor students:

- 1. Completion of at least 90 credits
- 2. Certified B2 level in English
- 3. Motivation letter (1 page) explaining the importance of the program to their studies and interests, along with their envisioned contributions.
 - 4. Portfolio (2-3 projects)

For Master students:

- 1. Motivation letter (1 page) explaining the program's significance to their studies and interests, along with their envisioned contributions.
- 2. Portfolio (2-3 projects)

Teaching Staff:

Priority will be given to mobility activities directly related to the BIP outlined in this call and to first-time participants in this type of mobility.

5. How to Apply

Students:

Interested students need to complete the <u>application form</u> by <u>June 6th, 2024</u>. The form should include the following attachments:

- 1. Motivation letter
- 2. English certificate (if not registered in their study career)
- 3. Portfolio (max 1 gigabyte)

Teaching Staff:

Interested teaching staff need to complete the <u>application form</u> by <u>June 6th, 2024</u>, including the teaching agreement as an attachment.

Rankings will be compiled by the appointed commission and communicated via email by June 18th, 2024. Successful candidates must accept or renounce the mobility within 5 days of the ranking's publication, following instructions provided by unibz. Vacancies resulting from non-acceptance or renunciation will be filled through the ranking list's sliding process.

7. Recognition of Mobility for Students

The international mobility period, conducted in its blended mode, is fully recognized within the educational pathway, subject to agreements made with the student's faculty and the host university through the Learning Agreement for Studies. Completion of the BIP programme, both physically and virtually, awards a minimum of 3 ECTS credits.

For recognition purposes, students must:

- Ensure availability of sufficient ECTS credits in their study plan for short-term physical mobility.
- Submit relevant documentation (transcript of records) attesting to their activities during the mobility period.

8. Personal Data Processing
