

## **STUDY MOBILITY ERASMUS+ (KA 131) & "BILATERAL AGREEMENTS" PROGRAMMES**

### **Call for Applications - academic year 2025/26**

Approved by Rector's Decree.

#### **ONLINE APPLICATION DEADLINE:**

**Monday, 3 March 2025, 12 noon**

### **1. STUDY MOBILITY PROGRAMMES**

For the academic year 2025/26 unibz issues a call for applications for study mobility in the following programmes:

- **The Erasmus+ Study Mobility Programme (KA 131):**  
This programme allows unibz students to spend a study period at universities abroad, which have signed a cooperation agreement with unibz. The duration of the stay is minimum 2 months and for a maximum of 12 months, according to the agreement signed with the partner university. The programme is promoted by the European Union.
- **The "Bilateral Agreements" Programme:**  
This programme offers study mobility opportunities regulated by bilateral agreements with countries not participating in the Erasmus+ Programme or with Italian universities. It allows students to spend a study period at universities which have signed a cooperation agreement with unibz.  
The "Bilateral agreements" programme is promoted by unibz.
- **The Swiss Mobility Programme:**  
The programme provides for study opportunities in Switzerland – which is not participating in the Erasmus+ Programme -, at universities that have signed a cooperation agreement with unibz.  
The financing of the mobility periods is borne by the Swiss universities.

During their stay at the host universities, which will have to be completed by **31 December 2026**, students will be required to carry out the learning/educational activities approved in the Learning Agreement before departure.

The students will benefit from the status of "exchange student", which entails the following advantages:

1. exemption from paying tuition fees at the host institution<sup>1</sup> (the student continues to be enrolled and to pay the university fees at unibz);
2. use of the services activated on partner's campus (canteens, library, etc.);
3. language courses;

4. the activities carried out abroad will be recognized by the relevant Faculty at unibz.

## 2. MOBILITY GRANTS

### 2.1. ERASMUS+ GRANTS FOR MOBILITY AND FOR SPECIAL NEEDS

The Erasmus+ grants consist of

- a) A monthly contribution from the European Union (or from unibz, should EU funds be depleted):
- for one semester mobility: based on the available funds, up to 5 monthly payments;
  - for two semesters mobility: based on the available funds, up to 10 monthly payments;
  - in case of actual mobility of less than 4 months for one semester and less than 8 months for two semesters, only the completed period will be funded

for mobilities towards:

The Erasmus Programme also **provides specific travel grants to cover the journey to the host country**, calculated based on the travel distance and the means of transport used. Mobile students are encouraged, whenever possible, to opt for environmentally sustainable travel options, such as trains, buses, or car sharing. The amounts of travel grants and the application procedures for the 2025/26 academic year are currently being defined by the Erasmus+ National Agency and will be promptly communicated to the selected beneficiaries.

- b) An additional flat-rate contribution is granted by unibz for each semester spent abroad:
- 500 € for one semester and for one or two quarters
  - 1,000 € for two semesters or three quarters

**Please note:** Mobility to the country of residence is not permitted under the Erasmus programme.

#### Additional Erasmus special funding opportunities

The European Union may provide special funding for students whose general health conditions or whose physical or mental conditions are such that they could not participate in the

programme without additional funding aimed at contributing to the additional costs deriving from those conditions. For example, the following services could be eligible for support according to the individual needs: special accommodation, travel assistance, medical assistance, support equipment, adaptation of the learning material, accompanying persons, etc. Students with special needs who win a grant will have to notify their condition upon acceptance and will then be supported by the International Relations Office in preparing their application to request any contribution.

We also suggest that you consult *MapAbility* - <https://esn.org/mapability-map> -, the online tool developed by the Erasmus Student Network (ESN) that shows the accessibility of higher education institutions and their services so that you will be able to make an informed choice about the destination of your mobility.

By signing the Erasmus Charter for Higher Education (ECHE) 2021-2027, unibz has committed itself to adhere to the principles of non-discrimination, transparency and inclusion of the Erasmus programme and to ensure equal opportunities for participants from all backgrounds, with particular attention to those with fewer opportunities.

Financial top-ups of 250 Euro per month (max. 5 monthly payments per semester) can therefore be awarded to those who are in a documented disadvantaged condition, i.e.: students with psychophysical health conditions, in economic disadvantage, from migratory backgrounds, students with minor children, orphans of at least one parent, student professional athletes, student workers and children of victims of terrorism or organised crime.

Extensions of the mobility period are normally not funded. unibz reserves the right to use any remaining European funds to finance authorized extensions within the limits of the available amounts. In any case, the flat-rate contribution from unibz is not granted in the event of an extension.

### **Erasmus Mobility within the European Alliance SUNRISE**

Starting from 1 January 2025, unibz is a partner of the European Alliance SUNRISE, a network that, over the next four years, will promote collaboration among nine European universities. The Alliance is committed to developing joint projects in the fields of teaching, research, and third mission activities. The educational focus of SUNRISE primarily involves STEAM disciplines (Science, Technology, Engineering, Arts, and Mathematics), in line with the academic offerings of the participating universities.

Thanks to the Erasmus programme, unibz students will have the opportunity to take part in mobility periods at the partner universities of the Alliance. Currently, Erasmus mobility agreements are in place with the following institutions:

## 2.2. "BILATERAL AGREEMENTS" MOBILITY GRANTS

Mobility students in the "Bilateral Agreements" exchange programme receive:

- a lump sum of **€ 1,750.00 gross** for an academic semester of mobility at one of the partner universities located in **Italy**;
- a lump sum of **€ 2,750.00 gross** for an academic semester of mobility at one of the partner universities located in the **USA, Canada, Australia, South Africa, Hong Kong (China), Taiwan, Japan, New Zealand**;
- a lump sum of **€ 2,000.00 gross** for an academic semester of mobility at one of the partner universities located in **all other non-European countries**.

Please note that the mobility grant is only meant as a financial supplement to cover the major expenses resulting from the stay abroad or at the partner universities in Italy. The mobility period within the "Bilateral Agreements" programme cannot be extended.

"Bilateral agreements" mobility grants are incompatible with any other form of funding awarded to support mobility by Italian bodies/organisations.

Students are hereby informed that, for destinations in Italy covered by specific agreements, the funds provided by the ministerial initiative "**Erasmus Italiano**" may be used as an alternative, where possible. This initiative, which is not connected to the European Erasmus+ programme, aims to promote student mobility within the national territory. Potentially, based on specific agreements and the confirmed availability of ministerial funds, the initiative offers a scholarship of up to a maximum of 1,000 Euros for each month of mobility. The "Erasmus italiano" funding is, in any case, accessible only to those students who can provide proof of an ISEE value not exceeding €36,000.00 for the previous year. If the conditions for accessing this funding are not met, the lump sum of 1,750 Euros gross will apply for an academic semester of mobility, funded by unibz.

## 2.3. MOBILITY GRANTS FOR SWITZERLAND – "SWISS MOBILITY"

The financing of the mobility period is borne by the Swiss universities. For the academic year 2025/26 the amount of the contribution is about **400.00 €** per month.

The flat-rate contribution from unibz is guaranteed also for the mobility to Switzerland:

- 500 € for one semester and for one or two quarters
- 1,000 € for two semesters or three quarters

The flat-rate contribution from unibz will not be granted in the event of an extension of the period of stay.



### 3. REQUIREMENTS FOR ADMISSION

#### a) Formal requirements

Applicants for the 2025/26 Study Mobility call must meet the following requirements in order to be eligible:

1. To be enrolled at unibz in the academic year of publication of this call (students enrolled in single subject courses are not eligible). Students enrolled in interuniversity programmes (eg., double/joint degrees) can apply for Erasmus+ destinations only if unibz is the programme's administrative seat. In the case of double enrolment in different degree courses, the student may apply for the destinations open to only one of the two courses and thus benefit from the potential mobility grant for only one of the courses.
2. Not to be enrolled beyond the regular time to attain the degree ("fuori corso") and to have duly effected all the payments for tuition fees by the departure date. Students, for whom the below cases apply are not eligible:
  - One-cycle master programmes (5 years): registration earlier than 2021
  - Bachelor: registration earlier than 2023
  - Master: registration earlier than 2024
3. to accept the provision, according to which exchange students are not allowed to graduate before they have completed their study period abroad;
4. to register by means of the online application form, filling in all information and attaching the documents that might be required (please see the paragraph on the submission of applications)

#### b) Language requirements

The language proficiency level you must attain within the deadline of this call is CEFR level B1 (Common European Framework of Reference) for the language/s required by the universities you are applying for.

Please follow the link to the [list of partner universities](#) and the relevant language requirements.

#### How can you certify your proficiency?

- For the **Italian, German and English** languages: reference will be made to the language proficiency level recorded in the student's academic career report at the date of deadline of this call (**3 March 2025**).
- For the **Spanish, French and – subject to reconfirmation – Portuguese** languages: proficiency shall be certified exclusively as follows:
  - a) by participating in a computer-based test (lasting approx. 60 minutes), organised by the Language Centre, which will take place on **19 February 2025, from 4 p.m.**, in room 1.02, at the Language Centre in piazza Domenicani 3, Bolzano, using laptops provided by unibz. Any tests/interviews taken at the Language Centre in previous academic years will not be considered valid. Registrations for the test must be submitted via email to [language.certification@unibz.it](mailto:language.certification@unibz.it), with the subject "Language Exam for Mobility Call," by **12 February 2025**; or
  - b) by submitting an international certificate – to be sent by the deadline of this call to [international.relations@unibz.it](mailto:international.relations@unibz.it) – that will need to be evaluated by the Language

Centre. In the case of a certification issued by an Italian public institution its attainment must be certified by submitting a self-declaration, in accordance with art. 46 of the Presidential Decree #445 dd. 28 December 2000.

For students attending study programmes taught in English only, the B1 proficiency level will be considered as attained and no further language certification will be required. Should these students choose universities where the teaching language is different from English, then the teaching language will need to be certified according to the above points.

#### **4. LENGTH AND INCOMPATIBILITY**

##### **4.1. Erasmus+**

Bachelor and Master students can take part in the Erasmus+ programme more than once. The maximum length for each study mobility period for Erasmus+, including the Erasmus+ Traineeship activities, are:

- 12 months per cycle (Bachelor, Master);
- 24 months in the case of a one-cycle degree (e.g. Master in Primary Education);
- Previous mobility experiences, whether financed or not, carried out under the Erasmus+ programme are included in the 12/24 month period stated above.

Furthermore:

- Mobility grant holders under the Erasmus programmes KA1+, Joint Master Degrees, or Erasmus Mundus cannot apply as it is not possible to benefit from both financial contributions for the same period of mobility;
- PhD scholarships from unibz are not compatible with Erasmus+ mobility grants;
- Students who are already granted EU contributions for stays abroad, which overlap with the Erasmus+ mobility period, cannot apply.

##### **4.2. Bilateral Agreements**

Students can participate in the "Bilateral Agreements" programme once per study cycle.

##### **4.3. Swiss European Mobility Programme**

Possible reasons for access limitations and incompatibilities shall be determined by the Swiss Universities. Please refer to each University's website.

##### **4.4. Maximum number of credits**

In compliance with the relevant Faculty's Study regulations, some Faculties have established a maximum number of credits that can be achieved during the exchange programmes (Erasmus+, Bilateral Agreements and Free Mover). Please refer to the decree with criteria approved by each Faculty.



## 5. CHOICE OF THE DESTINATIONS

Students should check on the website of the [partner universities](#) whether some of the terms could preclude departure, e.g.: application deadline is too close, the language requirements are too high, the course offer is incompatible.

For some destinations, priorities are set for the assignments. Please check all the information carefully.

If an offer is accompanied by the following statement: "offer not yet confirmed by the partner university", it means that the partner university had not yet signed the agreement by the time the call was launched. Therefore, choosing of these destinations does not guarantee that the winner will in fact benefit from this mobility.

We remind the students selected for an exchange programme that the final decision on their admission is up to the host universities and that unibz cannot guarantee that they can find a new destination.

### **Please note:**

For reasons related to the reorganisation of some of our partners, it is not possible to offer some destinations in the "Bilateral Agreements" programme in time before the closing date of this call for applications. Should some of these destinations become available at a later date, the International Relations Office reserves the right to make them available to successful candidates who have not yet been allocated an exchange place, while respecting the general ranking list.

## 6. ALLOWED ACTIVITIES E LEARNING AGREEMENT

### **Allowed activities**

In general, the allowed activities are:

- Educational activities (courses) and related assessment tests (exams)
- Preparation of the final dissertation
- Internships

Specifically, students are advised to check, which activities their Faculty allows to this purpose, please refer to each Faculty's information sheets.

### **Learning Agreement (LA)**

The Learning Agreement is the programme for the studies to be carried out at the partner university, which guarantees to the students that their study activities will be recognized by their home university upon their return.

Before departure, the student must draw up a LA together with the Faculty representative.

The approved LA must be appropriate to the length of the stay and lay down the requirement that the student acquire a number of curricular credits (CFU) equivalent to the corresponding period of study at the home university. Submitting a LA that does not comply with the credits required for the length of the stay makes it impossible for the student to participate in the exchange programme. For this purpose, please carefully read the unibz "*Regulation on student mobility within exchange programmes*" (available in Italian and German).





If the student also carries out an internship<sup>2</sup>, this must be included in the LA. Students of the Faculty of Education can include the internship in the LA as long as this is compatible with the standards required by the Faculty's regulation on internships. The academic internship tutor must be the same person appointed as the Faculty representative in charge of the signing of the Learning Agreement. In addition, the training period will have to be carried out under the supervision of the host institution.

The Learning Agreement is mandatory also in the case the students intend to prepare the final dissertation at the partner university. Please refer to the unibz "*Regulation on student mobility within exchange programmes*" (available in Italian and German).

### **Recognition**

At the end of the period of study, the Faculty will recognize the activities carried out during the mobility period basing on the certification issued by the partner university (the so-called "Transcript of records" or ToR) and on the LA.

Failure to achieve the minimum number of recognized curricular credits **results in the obligation to return the total amount of the grant** (see the unibz "*Regulation on student mobility within exchange programmes*", available in Italian and German).

## **7. SUBMISSION OF THE APPLICATION FORM**

All interested students must submit their application **exclusively [online](#) by 3 March 2025, at 12 noon.**

You can apply for a maximum of two destinations – exclusively among those available for your study programme – by order of preference (2 Erasmus+, or 2 Bilateral Agreements, or 1 Erasmus+ and 1 Bilateral Agreement) and you can express a preference for the semester in which you wish to carry out the mobility (the availability of the semester for which you have expressed a preference is not always guaranteed). Each student may take advantage of only one exchange placement per academic year.

Incomplete or inconsistently filled-in applications will be void. Technical problems in filling in the online form can only be taken into account if reported before the deadline.

**IMPORTANT:** After completing the online application process, the system automatically sends a confirmation email. It is the applicant's responsibility to ensure that they have received this email (also checking the spam folder) and to retain it. If the confirmation email is not delivered, the applicant must contact the International Relations Office for the necessary checks, in any case **before** the application deadline.

### CHECKLIST:

The online application must be fully filled in and be accompanied by the following documents:

<sup>2</sup> You may combine your study and internship into a single study period, provided that the following conditions are met:

- The internship must take place under the supervision of the host university;
- The internship must be included and approved in the Learning Agreement;
- In combined mobility, the duration of the internship must be less than 60 days.





- Language certificates for French, Spanish or Portuguese, if relevant;
- Only for the Faculty of Design and Art: Portfolio to be sent in PDF format (students of the Master in Eco-Social Design may alternatively send the link to the online portfolio) to Ms Elena Ghizzo – [elena.ghizzo@unibz.it](mailto:elena.ghizzo@unibz.it) - by **3 March 2025, 12 noon**.
- Only for those who intend to prepare their final dissertation at the partner institution: the "Proposal of Learning Activities for dissertation" form must be submitted to the International Relations Office by the deadline of this call, that is, **3 March 2025, 12 noon**.

## 8. SELECTION AND ACCEPTANCE PROCESS

The "General selection criteria for exchange programmes (Erasmus+ and Bilateral Agreements) for student mobility" (It/DE), approved by the Academic Senate, are available in full in the Study Guide.

Application evaluation Committees - appointed by each Faculty and composed of members of the academic body - draw up two rankings, one general and one for each individual destination. The score expressed in hundredths takes into account:

- credits achieved;
- grade point average;
- motivation containing the study project that the student intends to carry out in mobility with the partner. This item may be replaced and/or supplemented by the submission of a portfolio and/or a selection interview.

Further specifications to the criteria, including minimum score for eligibility, are set and approved by the individual Faculties. The approval resolutions with the specific criteria for each Faculty, available in the Study Guide, are considered an integral part of this call.

Each successful candidate following selection appears only once in the general ranking list and only once in the individual destination ranking lists. The latter take into account the preference expressed by the student at the application stage.

Should the score assigned for motivation/study project diverge between the two partner university preferences indicated, the higher score assigned to one of the two will be valid for the purposes of the general ranking.

The rankings are only valid for the academic year covered by the call for applications.

The rankings, general and by destination, show the total number of points awarded to the student.

In the event that the country of citizenship coincides with the country of the university chosen as the destination - limited to this choice - the student will be placed in the ranking after students whose citizenship does not coincide. For "bilateral agreement" mobility to partner universities in Italy, subject to the minimum language prerequisite of B1, no restrictions linked to the candidate's citizenship, nationality and/or residence apply when drawing up the ranking list for the individual destination.

The publication of the rankings is expected by **25 March 2025**.



### **Acceptance of the exchange mobility**

After the publication of the ranking lists, the winners must confirm the acceptance of the exchange destination by following the instructions that will be sent per email. After this deadline, all the winners who have not sent their confirmation of acceptance will lose their entitlement to the assigned destination.

### **Repechage checking of the winners' lists**

The International Relations Office will check the winners' lists – i.e. the office proceeds to the scrolling of the rankings by single study destination – by contacting the students via e-mail (@unibz.it) and requesting confirmation of acceptance or rejection within a given deadline, usually within 24 hours. In this case, too, failure to reply will result in exclusion from the relevant ranking list.

### **Residual places**

After the single destination lists' checking, residual places will be offered to suitable candidates on the basis of the general 2025/2026 ranking, in compliance with the requirements of this call. For this purpose, within the month of April 2025, the International Relations Office will contact the suitable candidates and submit the list of the residual destinations.

In cases of belated waivers, during the year the International Relations Office reserves the right to offer the vacant destinations to eligible students who are not assignees of mobility by first scrolling through the rankings for each destination and then through the general one. In any case, only the qualifications attained by the deadline of this call shall apply.

### **Responsibility of the winners**

Winners must:

1. Fulfill the administrative requirements (application procedure) set by the partner universities (application form, language certificates and other documentation, accommodation reservations etc.). It is part of the student's responsibility to gather all the necessary information about the administrative requirements and the deadlines set by the partner institutions as well as to comply with them, lest they might not be accepted by the partner university: please note that any relocation of a mobility cannot be guaranteed in the event of a failure to submit the documents requested by the partner university and/or in the event of a refusal of acceptance by the latter;
2. Prepare a Learning agreement together with the Faculty representative. Essential condition for attaining the status of "exchange student" and the mobility grant is that the LA be signed by the student, the Faculty representative and the partner university.
3. Sign an individual financial contract with unibz;
4. Inform the International Relations Office immediately in case of waiver due to serious and justified reasons. Please mind that a belated waiver and/or notice might cause another student to miss the opportunity of taking part in an exchange programme;
5. In the event the partner university requires a language proficiency level above B1, the student must certify the proficiency according to the procedures and deadlines set by the partner university.

Before departure, the winners are required to renew the enrolment at unibz for the academic year 2025/26.



**IMPORTANT:** In recent years the international scenario has seen a progressive change that has led to the appearance of new risk factors (e.g., political upheavals, acts of terrorism, natural disasters, health emergencies). Students are required to inform themselves in advance about the context of their country of destination also through the website "[Viaggiare Sicuri](#)" managed by the Ministry of Foreign Affairs. Students must be aware that a planned mobility could be hindered by a risk factor. In this case, the International Relations Office cannot guarantee the relocation of the mobility to another university in the event of cancellations due to force majeure, or for precautionary reasons, especially if they occur close to the departure to the original destination. In any case, any relocation may only take place within the academic year of reference of this call for applications, with the mobility to be concluded by 31 December 2026.

Finally, the stipulation of a worthwhile private health/travel insurance policy is essential, especially for non-European destinations. The travel insurance policy stipulated by unibz does not cover students who make a mobility to countries indicated as "at risk", even partial, before departure, as per the information available in the [Study Guide](#).

This call for applications has been translated from the Italian language. If there are any doubts concerning the language, the Italian version should be considered as valid.

Your personal data, collected today for the completion of the selection procedure and possibly additional to those provided at the time of enrollment at the University, are treated in compliance with the aforementioned regulation as well as with current regulations. As a participant in the selection process, your personal data necessary for the publication of the ranking will be published in the online Study Guide of the university together with the ranking points you achieved.
