## General terms and conditions for the use of websites based on WordPress provided by unibz.

## 1. Introduction

WordPress is a CMS, a platform for the creation of web pages.

Authors of WordPress can be members of the Press and Event Management Office, teaching staff, researchers or PhD students of unibz (hereinafter referred to as "User(s)"). A blog can be considered as a set of posts, even written by different authors, sorted chronologically and/or by arbitrary categories. Posts may be commented on by other users in the network; comments, in turn, may include the responses of other users and in this way it is possible to generate interesting discussions about the original content of the post.

WordPress is released under an open source license. The WordPress license conditions must be expressly accepted by the User: https://wordpress.org/about/license/

## 2. Terms of use

By using the WordPress service, the User expressly agrees to these Terms and Conditions.

- 1. The User acknowledges and accepts that the WordPress service is completely free of charge and that unibz is therefore not required to provide any advice, support service and/or warranty on the services, including quality, reliability, security, compatibility and condition.
- 2. The User declares and/or agrees:
  - a) that the User owns all rights to the uploaded content (hereinafter "Content"), including all drawings, images, animations, videos, audio files, fonts, logos, illustrations, compositions, works of art, interfaces, texts, literary works and any other material;
  - b) that the User Content is (and will continue to be) true and current, does not infringe upon the rights of third parties, and is owned, published, transmitted or displayed by the User in accordance with the laws in force in the country in which the User and/or visitors of the blog reside;

Under no circumstances can unibz be considered as a "publisher" of any of the User Content; unibz will never represent nor in any way approve the Content and will assume no responsibility for any Content uploaded, posted, published and/or made available by the User. Unibz will also not be held responsible for error, slander, defamation, falsehood, obscenity, pornography, incitement and/or any other illegal content and/or violation of the Content uploaded by the User. The User shall indemnify and hold unibz harmless from and against any and all claims, damages, losses, obligations, costs, debts and expenses (including legal fees) arising from the violation of these Terms of Use, as well as from the violation of third party rights, including any copyrights, property rights or privacy rights, arising from the User's blog or Content uploaded by the User, and/or from any other type of claim relating to any damages caused to third parties by the User's blog and/or Content uploaded by the User. The User will be responsible both for his own actions and for those of any thirdparty who accesses his Account.
